22 **COMES NOW**, Plaintiff FARREN MUSIC AMERICA, a Limited Liability Company dba  
23 GLOBAL CREATIVE GROUP ("GCG"), alleges against Defendants VIACOM INTERNATIONAL,  
24 INC., a Delaware corporation, (hereinafter referred to as "VIACOM"); BUNIM/MURRAY  
25 PRODUCTIONS, a California Limited Liability Company (hereinafter "BMP"); and DOES 1  
26 through 10, inclusive, as follows:

**THE PARTIES**

1  
2 1. Plaintiff GCG is an Arizona Corporation with a main place of business at 4757 East  
3 Greenway Road, Suite 107B – PMB180, Phoenix, Arizona 85032. GCG is in the business of  
4 producing and distributing media content, and the copyright holder of the materials that Defendants  
5 misappropriated for its own commercial benefit absent express consent from GCG.

6 2. Defendant VIACOM, upon information and belief, is a Delaware Corporation,  
7 headquartered at 1515 Broadway, New York, NY 10036. MTV NETWORKS (hereinafter referred to  
8 as “MTVN”) is a division of VIACOM that operates a portfolio of cable television networks,  
9 including MTV. MTV is the television channel responsible for airing the infringing television show  
10 “The Real World: New Orleans.”

11 3. Defendant BMP, upon knowledge and belief, is a California Limited Liability  
12 Company, headquartered at 6007 Sepulveda Blvd., Van Nuys, CA 91411. BMP is in the business of  
13 producing and distributing media content. BMP is the creator and producer of “The Real World,”  
14 which airs on MTV (a channel of co-defendant VIACOM and its division MTVN).

15 4. At present, the true names and capacities, whether individual, corporate, or otherwise of  
16 Defendants DOES 1 through 10 are unknown to Plaintiff and Plaintiff therefore sues these individuals  
17 by their fictitious names and capacities in place of their legal names, but asks leave to amend with  
18 their legal names if and when Plaintiff identifies them.

19 5. Upon information and belief, DOES 1-10 have acted or failed to act in concert with  
20 Defendants as alleged herein, and are responsible in some manner for the injuries and damages  
21 suffered by Plaintiff. All references to "DEFENDANTS" shall be deemed to include Defendants and  
22 DOES 1-10.

23 6. At all times mentioned herein, unless otherwise stated, each Defendant was the agent,  
24 employee, servant, or representative of each of the remaining Defendants, and in doing the acts  
25 alleged herein, was acting within the course and scope of that agency, employment, service, and  
26 representation, and with the knowledge, ratification, approval, authorization, and consent of each of  
27 the other Defendants, and/or their officers and/or managing agents.

**JURISDICTION AND VENUE**

7. This court has jurisdiction over this action pursuant to the Copyright Act of 1976, Title 17, United States Code, § 101, et seq. and also Title 15, United States Code, § 1051, et seq. and also Title 18, United States Code § 1964, et seq.

8. Jurisdiction of the subject matter is conferred on this court by 28 United States Code §§ 1331 and 1338.

9. Venue is proper under 28 United States Code § 1391

10. This Court has personal jurisdiction over Defendants (and all DOE defendants) since defendant BMP is a California LLC headquartered in this district and defendant VIACOM and its division MTVN conduct business within the district of this Court. Defendant's misconduct occurred in this judicial district, and others, as a result of MTVN's broadcasting Plaintiff's copyrighted material over the airways of this specific district (and others). Because Defendants aired Plaintiff's property without proper authority and, in addition, failed to compensate Plaintiff for the same, Plaintiff has suffered, and continues to suffer harm in this district (as well as others).

**GENERAL ALLEGATIONS**

11. GCG provides visual entertainment titled "Shadow Dancers" that is specifically catered to the service and hospitality industry. The company provides select hardware, downloadable and DVD video visuals, as well as custom content for various professional needs. Plaintiff's products are used by a variety of persons and businesses, including VJs, DJs, bar and club owners, party planners, retailers, nightlife establishments, and others. GCG's products may be purchased through various standard media outlets, such as Amazon.com, retail stores, Best Buy and others.

12. GCG owns and administers the copyrights of said products and has invested substantial money, time, effort, and creative talent to protect and properly develop its copyrighted materials.

13. Defendant BMP produces a variety of reality television programs that are shown nationally on various cable channels. BMP is responsible for creating and producing the television series "The Real World," which airs on co-defendant's channel MTV.

1 14. VIACOM is a media conglomerate with many divisions and subsidiaries, including  
2 MTVN. MTVN is a division of VIACOM that operates various cable television networks, including  
3 MTV, which airs “The Real World.”

4 15. On or about July 14, 2010 and July 21, 2010, Episodes 3 and 4, respectively, of “The  
5 Real World: New Orleans” aired on MTV. “Shadow Dancers” Volumes 2, 4, 6 and VJ World  
6 Revolutions are shown at various times throughout the aforementioned episodes. Both episodes  
7 contained clear images of “Shadow Dancers” in the background of scenes in bars/clubs and on the  
8 streets of New Orleans.

9 16. Subsequently thereafter, Plaintiff became aware that Defendants, including DOE  
10 defendants, unlawfully incorporated images of its products, namely “Shadow Dancers” Volumes 2, 4,  
11 and 6 and VJ World Revolutions, in episodes 3 and 4 of “The Real World: New Orleans.”  
12 Defendants’ unauthorized use of Plaintiff’s creative work materially enhanced Defendants’ program  
13 to the detriment of Plaintiff and Plaintiff’s brand. Such display was conducted without Defendants’  
14 obtaining a public performance license or any permission from the copyright holder, GCG.

15 17. On or about September 28, 2010 counsel for Plaintiff sent a letter to the legal  
16 department of MTVN describing Defendants’ infringement of Plaintiff’s copyrights and discussing  
17 the ramifications of such infringement. Said letter also included a demand for reasonable  
18 compensation for aforementioned and previous unlawful use of Plaintiff’s copyrights as well as  
19 offered Defendants a license to use “Shadow Dancers.” Plaintiff made it clear to Defendants that  
20 GCG, at the time of said letter, was “willing to settle this matter short of litigation and grant an  
21 unlimited use license to MTVN to use any ‘Shadow Dancers’ material in their shows for the next five  
22 (5) years at the rate of \$100,000.00.”

23 18. On or about November 1, 2010, Plaintiff received a letter from MTVN stating it had  
24 forward claims concerning “The Real World” to BMP. In addition, MTVN stated it felt that its use of  
25 “Shadow Dancers” was *de minimis* and/or constituted fair use of Plaintiff’s copyrighted materials.

26 19. At no point in time have Defendants acquired a public performance license or otherwise  
27 obtained any authorization for the public display of images from Plaintiff’s products.

1 20. Upon information and belief, by virtue of the foregoing described facts, Defendants  
2 have made substantial profits and saved significantly on advertising costs—profits and savings to  
3 which they are not entitled—as a result of using Plaintiff’s copyrighted products without a license.

4 **FIRST CAUSE OF ACTION**

5 **(Copyright Infringement against All Defendants and Does 1 – 10)**

6 21. Plaintiff incorporates, as though fully set forth herein, paragraphs 1 through 20 of this  
7 Complaint.

8 22. The copyright for “Shadow Dancers Vol. 2” was filed with the Copyright Office on  
9 February 6, 2009 and has a Copyright Registration Number of PA 1-621-672.

10 23. Plaintiff is the sole author and creator of all other audiovisual work known as “Shadow  
11 Dancers” as protected under the Copyright Act, 17 U.S.C. § 101 et seq.

12 24. On or about July 14, 2010 and July 21, 2010, Episodes 3 and 4, respectively, of “The  
13 Real World: New Orleans” aired on MTV. Shadow Dancers are clearly shown in the background of  
14 scenes in a bar/club and on the streets of New Orleans in the aforementioned episodes, as well as in  
15 trailers/promotional material for the show.

16 25. In violation of 17 U.S.C.A. § 106, Defendants have willfully infringed upon Plaintiff’s  
17 copyrighted work by publicly reproducing, adapting, distributing, and/or displaying Plaintiff’s work  
18 without consent, approval, or license.

19 26. Defendants, at no time, attempted to contact Plaintiff in order to acquire a license to  
20 publicly perform and/or display Plaintiff’s copyrighted work during Episodes 3 and 4 of “The Real  
21 World: New Orleans.” As a result of said failure, Defendants have improperly received a commercial  
22 benefit to their reputations and names at the expense of Plaintiff’s time, money, and effort invested in  
23 creating “Shadow Dancers.”

24 27. As a direct and proximate result of the infringements by Defendants, Plaintiff is entitled  
25 to actual damages in an amount yet to be determined. Alternatively, Plaintiff is entitled to maximum  
26 statutory damages of \$150,000 for each copyright infringed, or in such other amount as may be  
27 proper under 17 U.S.C. § 504 (c).

1 28. Defendants' infringement of Plaintiff's copyright has yielded Defendants profits in an  
2 amount to be determined.

3 29. Plaintiff, GCG, is further entitled to its attorney's fees and full costs pursuant to 17  
4 United States Code § 505.

5 30. As a result of Defendants' conduct, Plaintiff has sustained and will continue to sustain,  
6 substantial, immediate, and irreparable injury, for which there is no adequate remedy at law. Plaintiff  
7 is informed and believes, and on that basis avers, that unless enjoined and restrained by this Court,  
8 Defendants will continue to infringe its rights in its products. Plaintiff is entitled to preliminary and  
9 permanent injunctive relief to restrain and enjoin Defendants' continuing infringing conduct.

10 **SECOND CAUSE OF ACTION**

11 **(Unjust Enrichment against All Defendants and Does 1-10)**

12 31. Plaintiff incorporates, as though fully set forth herein, paragraphs 1 through 30 of this  
13 Complaint.

14 32. Defendants unlawfully used, Plaintiff's copyrighted work entitled "Shadow Dancers,"  
15 in two episodes of "The Real World: New Orleans," without authorization, obtaining a license, or  
16 otherwise compensating Plaintiff for said use.

17 33. Plaintiff has invested massive amounts of capital, labor, and time over at least the last  
18 seven (7) years to create the aforementioned products and systems.

19 34. Defendants have failed to pay for the full value of the services received.

20 35. Accordingly, Defendants have been unjustly enriched in an amount to be proven at  
21 trial.

22 36. Plaintiff has been unjustly deprived of potential licensing and other revenue as a  
23 proximate result of Defendants' actions in an amount to be proven at trial.

24 **THIRD CAUSE OF ACTION**

25 **(Injunctive Relief against All Defendants and Does 1-10)**

26 37. Plaintiff incorporates, as though fully set forth herein, paragraphs 1 through 36 of this  
27 Complaint.

1 38. Plaintiff also requests injunctive relief against Defendants. Specifically, Plaintiff seeks  
2 permanent and final injunctions on such terms as it may deem reasonable to prevent or restrain future  
3 infringement of said copyrights.

4 **PRAYER FOR RELIEF**

5 WHEREFORE, Plaintiff requests the following relief:

6 a. On the first count for relief, damages in an amount to be determined at trial, which upon  
7 information and belief, exceed the sum of \$25,000;

8 b. On the second count for relief, damages in an amount to be determined at trial, equal to  
9 the amount that Defendants have been unjustly enriched;

10 c. On the third count for relief, immediate and permanently enjoining Defendants, their  
11 officers, directors, agents, servants, employees, representatives, attorneys, related companies,  
12 successors, assigns, and all others in active convert or participation with them from copying and  
13 republishing any of Plaintiff's copyrighted material without consent or otherwise infringing Plaintiff's  
14 copyrights in any manner;


15 d. The costs and disbursement of this action including reasonable attorney's fees together  
16 with such other and further relief that this Court may deem just and proper.

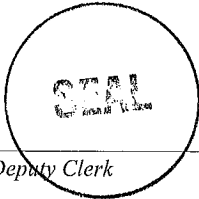

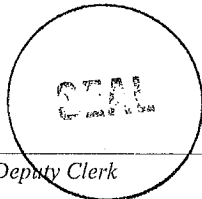
