# **PRESENTERS & TOPICS**

### "A Story of Triumph Over Tragedy" by Michelle Corrao

Michelle is the Assistant Director for Prevail, a victim awareness and support program in Hamilton County Indiana. She has been with Prevail for fourteen years and has held a number of positions including Sexual Assault Advocate, Director of Community Relations and Interim Executive Director. Michelle has been the featured presenter at regional conferences in Indiana, Idaho, Michigan, New Hampshire, and Austin, TX sharing her story to promote healing, hope and awareness of sexual assault. She was honored in Washington D.C. by US Attorney General Eric Holder with the "Special Courage Award" and was the first to receive the "Distinguished Hoosier Award", by Governor Mitch Daniels and Indiana Attorney General Greg Zoeller. Michelle has also been featured on the Biography Channel series "I Survived".

#### "Can you "Cure" a Sex Offender" by Denise M. Ackermann, MSW, LCSW

Denise holds a Masters degree in Social Work from Indiana University and is a Licensed Clinical Social Worker with the state of Indiana. She has been employed in the mental health field since 1996. As of 2001, Denise has worked in the field of illegal and maladaptive sexual behaviors in a variety of settings (prisons and in the communities) with both the adult and juvenile populations. Denise was recognized as Indiana's "Provider of the Year" in 2012 by IN SOMM (Indiana's Sex Offender Management & Monitoring program) and became a board member of MRNISO in 2015.

#### Masters of Manipulation by Kristina Korobov

Kristina is the Supervisor of the Special Victims Team and the Director of Prosecutor Education at the Marion County Prosecutor's Office in Indianapolis, Ind. In this position, she is responsible for meeting the training needs of the attorneys in her office. Kristina supervises all attorneys and staff who handle sex crimes, crimes against children, and domestic violence cases at the screening, felony and misdemeanor levels. She also serves as the office point-person on child abuse homicides. Kristina has been prosecuting cases involving domestic and sexual violence and child abuse cases since 1997. In 2013, she received the Visionary Voice Award from the National Sexual Violence Resource Center. Kristina also serves on the Board for MNRISO.

#### Vicarious Trauma presented by The Legacy House

The Legacy House provides advocacy, counseling and support services to children and adults affected by trauma and/or all types of violence. Their eight counselors and two comfort dogs provide services to victims of criminal violence including but not limited to sexual assault, childhood sexual abuse, domestic violence, home invasions and homicides. Their services included individual and group counseling, assistance with victim compensation applications and temporary emergency protective orders, and case management assistance.
